

Bilag 3.**Konvention.**

Hans Majestæt Kongen af Danmark og Hans Majestæt Kongen af det Forenede Kongerige Storbritannien og Irland og af de Britiske oversøiske Besiddelser, Kejser af Indien, der have undertegnet Konventionen angaaende fredelig Bilæggelse af internationale Stridigheder, afsluttet i Haag den 29de Juli 1899;

Have, i Betragtning af, at de høje kontraherende Parter ved Artikel 19 i nævnte Konvention have forbeholdt sig at slutte Overenskomster med Hensyn til at henvise til Voldgift alle Spørgsmaal, som de maatte anse det for muligt at underkaste saadan Behandling,

Udnævnt til deres Befuldmægtigede: —

Hans Majestæt Kongen af Danmark, Herr Frants Ernst Bille, Hans Majestæts Kammerherre og overordentlige Gesandt samt befuldmægtigede Minister i London, Storkors af Danebrog og Danebrogsmænd, etc.; og

Hans Majestæt Kongen af det Forenede Kongerige Storbritannien og Irland og af de Britiske oversøiske Besiddelser, Kejser af Indien, Most Honourable Henry Charles Keith Petty-Fitzmaurice, Markis af Lansdowne, Hans Majestæts Første Statssekretær for udenrigske Anliggender;

Hvilke, efter at have meddelt hinanden deres respektive Fuldmagter, der befandtes i god og rigtig Form, ere komne overens om følgende Bestemmelser: —

Convention.

His Majesty the King of Denmark and His Majesty the King of the United Kingdom of Great Britain and Ireland and of the British Dominions beyond the Seas, Emperor of India, signatories of the Convention for the pacific settlement of international disputes, concluded at The Hague on the 29th July 1899;

Taking into consideration that by Article 19 of that Convention the High Contracting Parties have reserved to themselves the right of concluding Agreements, with a view to referring to arbitration all questions which they shall consider possible to submit to such treatment,

Have named as their Plenipotentiaries to conclude the following arrangement: —

His Majesty the King of Denmark, Mr. Frants Ernst de Bille, his Chamberlain and Envoy Extraordinary and Minister Plenipotentiary at London, Grand Cross of the Order of Danebrog, and decorated with the Silver Cross of the same Order, &c.; and

His Majesty the King of the United Kingdom of Great Britain and Ireland and of the British Dominions beyond the Seas, Emperor of India, the Most Honourable Henry Charles Keith Petty-Fitzmaurice, Marquess of Lansdowne, His Majesty's Principal Secretary of State for Foreign Affairs;

Who, after having communicated to each other their respective full powers, found in good and due form, have agreed as follows: —
