

2. The Official Representatives shall in the exercise of their functions have free access to the Foreign Minister of the country, wherein they reside. They shall further be at liberty to communicate freely with their own Government and with official representatives of their Government in other countries by post, by telegraph and by wireless telegraphy also in cipher and to receive and dispatch couriers with sealed bags subject to a limitation of 10 kg. pr. week which bags shall be exempt from examination. Such couriers shall be nationals of the country of the Delegation. The Official Representatives shall also have right to receive, by couriers and mail, periodicals and books published in their own country for their personal use and for the benefit of their staff in reasonable quantities. The telegrams and radiotelegrams of the Official Representatives shall enjoy any right of priority over private messages which is generally accorded to the messages of official representatives of other foreign Governments in both countries respectively.

3. The Official Representatives shall be the competent authorities to issue passports and other documents of identity and nationality, to grant visas, legalize documents and perform other duties of this kind which belong to official representatives of the other foreign Governments in the country in question.

4. The Official Representatives as well as their personnel of their own nationality admitted to the respective territories in pursuance of this Agreement within the territories of the other party shall enjoy such immunity as to persons, private property, residence and offices and exemption from taxation as is usually granted to the diplomatic representatives of other countries and their personnel in accordance with international law.

2. De officielle Repræsentanter skal under Udøvelsen af deres Virksomhed have fri Adgang til Udenrigsministeren i det Land, hvori de er bosat. De skal endvidere uhindret kunne korrespondere med deres egen Regering og deres Regerings officielle Repræsentanter i andre Lande pr. Post, Telegraf og Radiotelegraf, derunder i Chiffer, samt modtage og afsende Kurerer, der skal kunne medføre forseglede Forsendelser indtil en samlet Vægt af 10 kg pr. Uge, som skal være fritaget for Undersøgelse. Disse Kurerer skal være Statsborgere i Delegationens Hjemland. De officielle Repræsentanter skal endvidere have Ret til i rimeligt Omfang pr. Kurer eller Post at modtage Tidsskrifter og Bøger, offentliggjort i deres eget Land, til deres eget eller deres Personales Brug. De officielle Repræsentanters Telegrammer og Radiotelegrammer skal nyde den Fortrinsret fremfor private Telegrammer, som i Almindelighed indrømmes andre fremmede Regeringers officielle Repræsentanter i de respektive Lande.

3. De officielle Repræsentanter skal være de kompetente Myndigheder til at udstede Pas og andre Identitets- og Nationalitetsbeviser, meddele Visa, legalisere Dokumenter og foretage andre lignende Embedsforretninger, som tilkommer andre fremmede Regeringers officielle Repræsentanter i det paagældende Land.

4. De officielle Repræsentanter samt deres Personale af deres egen Nationalitet, som har faaet Adgang til de respektive Omraader i Medfør af nærværende Overenskomst, skal indenfor den anden Parts Omraade nyde saadan Ukrænkelighed med Hensyn til Person, privat Ejendom, Bolig og Embedslokale samt Fritagelse for Beskatning, som sædvanlig tilstaaes andre Landes diplomatiske Repræsentanter og deres Personale i Overensstemmelse med Folkeretten.
