

Dag efter Udvekslingen af Ratifikationsdokumenterne.

Slutprotokollen indeholder i Stykke 1 et dansk Forbehold med Hensyn til de Begunstigelser, som Danmark har givet eller i Fremtiden maatte give Island, i Stykke 2 den skandinaviske Forbeholdsklausul og i Stykke 3 Forbehold med Hensyn til Grønland; dog fastsættes Mestbegunstigelsesbehandling for grønlandske Varer i Siam respektive for siamesiske Varer i Grønland.

I Stykke 4 aftales — som allerede omtalt — at Mestbegunstigelsesbehandlingen

med Hensyn til fast Ejendom, som er fastsat i Artikel 2, Stykke 7 og i Artikel 7, Stykke 4, er tilstaaet paa Betingelse af Gensidighed; jfr. den ligeledes omtalte Noteveksling, der refererer sig til denne Bestemmelse (Bilag 2).

Stykke 5 supplerer de i Traktaten givne Nationalbehandlingstilsagn for de respektive Parters Statsborgere og Skibe med et Tilsagn om Mestbegunstigelsesbehandling.

Stykke 6 bestemmer, at Mestbegunstigelsesbehandlingen, som er fastsat i Traktaten, skal tilstaaes straks og ubetinget.
