

(6) In order to enable urgent military measures to be taken by the Organisation, there should be held immediately available by the members of the Organisation national Air Force contingents for combined international enforcement action. The strength and degree of readiness of these contingents and plans for their combined action should be determined by the Security Council, with the assistance of the Military Staff Committee, within the limits laid down in the special agreement or agreements referred to in paragraph (5) above.

(7) The action required to carry out the decisions of the Security Council for the maintenance of international peace and security should be taken by all the members of the Organisation in co-operation or by some of them as the Security may determine. This undertaking should be carried out by the members of the Organisation by their own action and through action of the appropriate specialised Organisations and agencies of which they are members.

(8) Plans for the application of armed force should be made by the Security Council with the assistance of the Military Staff Committee referred to in paragraph (9) below.

(9) There should be established a Military Staff Committee, the functions of which should be to advise and assist the Security Council on all questions relating to the Security Council's military requirements for the maintenance of international peace and security, to the employment and command of forces placed at its disposal, to the regulation of armaments and to possible disarmament. It should be responsible under the Security Council for the strategic direction of any armed forces placed at the disposal of the Security Council. The Committee should be composed of the Chiefs of Staff of the permanent members of the Security Council or their representatives. Any member of the Organisation not permanently represented on the Committee should be invited by the Committee

6) For at sætte Organisationen i Stand til at iværksætte paatrængende militære Forholdsregler skal Medlemmerne af Organisationen, holde Kontingenter af det nationale Luftvaaben rede til øjeblikkelig Anvendelse ved en fælles mellemfolkelig Tvangsforanstaltning. Indenfor de Rammer, der er fastlagt i den særlige Overenskomst eller de særlige Overenskomster, som omhandles under Punkt 5, skal Sikkerhedsraadet med Bistand af Generalstabskomitéen træffe Bestemmelse om disse Kontingenters Styrke og Beredskabsgrad samt om Planerne for deres fælles Aktion.

7) De Skridt, der udkræves for at gennemføre Sikkerhedsraadets Beslutninger til Opretholdelse af mellemfolkelig Fred og Sikkerhed, skal foretages af alle Medlemmer af Organisationen i Fællesskab eller nogle af disse efter Sikkerhedsraadets Bestemmelse. Denne Forpligtelse skal opfyldes af Organisationens Medlemmer ved Skridt foretaget af dem selv og ved Skridt foretaget af vedkommende særlige Organisationer og Institutioner, hvoraf de er Medlemmer.

8) Planerne for Anvendelse af væbnet Magt skal udarbejdes af Sikkerhedsraadet med Bistand af den under Punkt 9 omtalte Generalstabskomité.

9) Der skal oprettes en Generalstabskomité, hvis Opgaver skal være at raade og bistaa Sikkerhedsraadet i alle Spørgsmaal vedrørende Sikkerhedsraadets militære Behov med Henblik paa Opretholdelsen af mellemfolkelig Fred og Sikkerhed, Anvendelsen af og Kommandoen over de Styrker, der er stillet til dets Raadighed, samt Reguleringen af Rustningerne og mulig Afrustning. Den skal under Sikkerhedsraadets Myndighed være ansvarlig for den strategiske Ledelse af alle væbnede Styrker, der er stillet til Raadighed for Sikkerhedsraadet. Komitéen skal bestaa af Sikkerhedsraadets faste Medlemmers Generalstabschefer eller deres Repræsentanter. Ethvert Medlem af Organisationen, som ikke er fast repræsenteret i Komitéen, skal indbydes af denne til at slutte sig til den, naar den effektive Ud-
