

- (a) To carry out, within the scope of its functions, recommendations of the General Assembly;
- (b) To make recommendations on its own initiative with respect to international, economic, social and other humanitarian matters;
- (c) To receive and consider reports from the economic, social and other organisations or agencies brought into relationship with the Organisation, and to co-ordinate their activities through consultations with, and recommendations to, such organisations or agencies;
- (d) To examine the administrative budgets of such specialised organisations or agencies with a view to making recommendations to the organisations or agencies concerned;
- (e) To enable the Secretary-General to provide information to the Security Council;
- (f) To assist the Security Council upon its request; and
- (g) To perform such other functions within the general scope of its competence as may be assigned to it by the General Assembly.

*(D) Organisation and Procedure.*

(1) The Economic and Social Council should set up an Economic Commission, a Social Commission, and such other Commissions as may be required. These Commissions should consist of experts. There should be a permanent staff which should constitute a part of the Secretariat of the Organisation.

(2) The Economic and Social Council should make suitable arrangements for representatives of the specialised organisations or agencies to participate without vote in its deliberations and in those of the commissions established by it.

(3) The Economic and Social Council should adopt its own rules of procedure and the method of selecting its president.

- a) inden for Rammen af dets Funktioner at gennemføre Plenarforsamlingens Forslag;
- b) paa eget Initiativ at fremsætte Forslag vedrørende mellemfolkelige økonomiske, sociale og andre humanitære Emner;
- c) at modtage og behandle Beretninger fra de økonomiske, sociale og andre Organisationer eller Institutioner, som er bragt i Forbindelse med Organisationen, og bringe deres Virksomhed i indbyrdes Overensstemmelse gennem Samraad med og Forslag til saadanne Organisationer eller Institutioner;
- d) at gennemgaa Administrationsbudgetterne for saadanne Specialorganisationer og Institutioner med Henblik paa Fremstættelse af Forslag over for vedkommende Organisation eller Institution;
- e) at sætte Generalsekretæren i Stand til at skaffe Sikkerhedsraadet Oplysninger;
- f) at bistaa Sikkerhedsraadet paa dettes Anmodning samt
- g) at udføre saadanne andre Funktioner inden for Rammerne for dets almindelige Beføjelser, som maatte blive tillagt det af Plenarforsamlingen.

*(D) Organisation og Forretningsgang.*

1) Det økonomiske og sociale Raad skal oprette en økonomisk Kommission, en social Kommission og saadanne andre Kommissioner, som maatte være paakrævede. Disse Kommissioner skal bestaa af Sagkyndige. Der skal findes et fast Personale, som skal udgøre en Del af Organisationens Sekretariat.

2) Det økonomiske og sociale Raad skal træffe hensigtsmæssige Foranstaltninger til, at Repræsentanter for de særlige Organisationer eller Institutioner kan deltagte uden Stemmeret i dets Forhandlinger og i de af det oprettede Kommissioners Forhandlinger.

3) Det økonomiske og sociale Raad skal selv vedtage sin Forretningsorden og Fremgangsmaaden ved Valg af sin Formand.
