

CHAPTER X.—THE SECRETARIAT.

(1) There should be a secretariat comprising a Secretary-General and such staff as may be required. The Secretary-General should be the chief administrative officer of the Organisation. He should be elected by the General Assembly on recommendation of the Security Council, for such term and under such conditions as are specified in the Charter.

(2) The Secretary-General should act in that capacity in all meetings of the General Assembly, of the Security Council, and of the Economic and Social Council, and should make an annual report to the General Assembly on the work of the Organisation.

(3) The Secretary-General should have the right to bring to the attention of the Security Council any matter which in his opinion may threaten international peace and security.

CHAPTER XI.—AMENDMENTS.

Amendments should come into force for all members of the Organisation when they have been adopted by a vote of two-thirds of the members of the General Assembly and ratified in accordance with their respective constitutional processes by the members of the Organisation having permanent membership on the Security Council and of a majority of the other members of the Organisation.

CHAPTER XII.—TRANSITIONAL ARRANGEMENTS.

(1) Pending the coming into force of the special agreement or agreements referred to in Chapter VIII, section (B), paragraph (5), and in accordance with the provisions of paragraph 5 of the Four-Nation Declaration, signed at Moscow, the 30th October, 1943, the States parties to that declaration should consult with one another and as occasion arises with other members of the Organi-

KAPITEL X. SEKRETARIATET.

1) Der skal være et Sekretariat, bestaaende af en Generalsekretær og et saadant Personale, som maatte behøves. Generalsekretæren skal være Organisationens øverste administrerende Embedsmand. Han skal vælges af Plenarforsamlingen paa Forslag af Sikkerhedsraadet for det Tidsrum og paa de Betingelser, som bestemmes i Pagten.

2) Generalsekretæren skal handle i denne Egenskab ved alle Plenarforsamlingens, Sikkerhedsraadets og det økonomiske og sociale Raads Møder og skal udarbejde en aarlig Beretning til Plenarforsamlingen om Organisationens Arbejde.

3) Generalsekretæren skal have Ret til at henlede Sikkerhedsraadets Opmærksomhed paa enhver Sag, som efter hans Mening kan true mellemfolkelig Fred og Sikkerhed.

KAPITEL XI. ÆNDRINGER.

Ændringer skal træde i Kraft for alle Medlemmer af Organisationen, naar de er blevet vedtaget af to Trediedele af Medlemmerne af Plenarforsamlingen og ratificeret i Overensstemmelse med deres respektive forfatningsmæssige Fremgangsmaader af de Medlemmer af Organisationen, som er fast repræsenteret i Sikkerhedsraadet, samt af Flertallet af de andre Medlemmer af Organisationen.

KAPITEL XII. OVERGANGSBESTEMMELSER.

1) Indtil Ikrafttræden af den eller de i Kapitel VIII, Afsnit B, Stk. 5, omtalte særlige Overenskomster og i Overensstemmelse med Bestemmelserne i Pkt. 5 i den i Moskva den 30. Oktober 1943 undertegnede Firemagtsdeklaration, skal de Stater, der har undertegnet nævnte Deklaration, raadføre sig med hverandre og, naar Anledning opstaar dertil, med andre Medlemmer af
