

expert personnel, and staff at his headquarters and elsewhere, including field missions, as he shall find necessary, and he may delegate to them such of his powers as he may deem appropriate. The Director-General, or upon his authorisation the Deputy Directors-General, shall supply such secretariat and other staff and facilities as shall be required by the Council and its committees, including the regional committees and subcommittees. Such Deputy Directors-General as shall be assigned special functions within a region shall attend meetings of the regional standing committee whenever possible and shall keep it advised on the progress of the relief and rehabilitation programme within the region.

5. The Director-General shall make periodic reports to the Central Committee and to the Council covering the progress of the Administration's activities. The reports shall be made public except for such portions as the Central Committee may consider it necessary, in the interest of the United Nations, to keep confidential; if a report affects the interests of a member Government in such a way as to render it questionable whether it should be published, such Government shall have an opportunity of expressing its views on the question of publication. The Director-General shall also arrange to have prepared periodic reports covering the activities of the Administration within each region and he shall transmit such reports with his comments thereon to the Council, the Central Committee and the respective regional committees.

Article V.

Supplies and Resources.

1. In so far as its appropriate constitutional bodies shall authorise, each member Government will contribute to the support of the Administration in order to accomplish the purposes of article I, paragraph 2 (a). The amount and character of the contri-

Generaldirektøren, eller efter hans Bemyndigelse Vice-Generaldirektørerne, opretter, forsaavidt Raadet og dets Komitéer, herunder de regionale Komitéer og Underkomitéer, finder det paakrævet, Sekretariater, ansætter Personale og anskaffer de nødvendige Hjælpemidler. De Vice-Generaldirektører, til hvem der maatte blive overdraget særlige Funktioner inden for et givet Omraade, skal saavidt muligt overvære de staaende regionale Komitéers Møder og holde dem underrettet om Hjælpe- og Genopbygningsvirksomheden inden for det paagældende Omraade.

5. Generaldirektøren indgiver periodiske Beretninger til Centralkomiteén og til Raadet angaaende Forvaltningens Virksomhed. Beretningerne offentliggøres, bortset fra de Dele heraf, som Centralkomiteén i De Forenede Nationers Interesse maatte finde det nødvendigt at hemmeligholde. Hvis en Beretning berører en Medlemsstats Interesser paa en saadan Maade, at det maa anses for tvivlsomt, om den bør offentliggøres, afæskes vedkommende Medlemsstats Regeering en Udtalelse angaaende Spørgsmalet om Offentliggørelse. Generaldirektøren lader ligeledes udarbejde periodiske Beretninger om Forvaltningens Virksomhed inden for de enkelte Omraader, hvilke Beretninger, ledsaget af hans Bemærkninger, vil være at tilstille Raadet, Centralkomiteén og de paagældende regionale Komitéer.

Artikel V.

Forsyninger og Hjælpekilder.

1. Hver Medlemsstats Regeering vil i den Ustrækning, Bemyndigelse gives af dens forfatningsmæssige Organer, yde Bidrag til Forvaltningen med Henblik paa Gennemførelsen af de i Artikel I, Pkt. 2 (a) nævnte Formaal. Størrelsen og Arten af
