

a. member of the Fund as from the date of the deposit on its behalf of the instrument referred to in (a) above, except that no government shall become a member before this Agreement enters into force under Section 1. of this Article.

(c) The Government of the United States of America shall inform the governments whose names are set forth in Schedule A and all governments whose membership is approved in accordance with Article II, Section 2, of all signatures of this Agreement and of the deposit of all instruments referred to in (a) above.

(d) At the time this Agreement is signed on its behalf, each government shall transmit to the Government of the United States of America one one-hundredth of one percent of its total subscription in gold or United States dollars for the purpose of meeting administrative expenses of the Fund. The Government of the United States of America shall hold such funds in a special deposit account and shall transmit them to the Board of Governors of the Fund when the initial meeting has been called under Section 3 of this Article. If this Agreement has not come into force by December 31, 1945, the Government of the United States of America shall return such funds to the governments that transmitted them.

(e) This Agreement shall remain open for signature at Washington on behalf of the governments of the countries whose names are set forth in Schedule A until December 31, 1945.

(f) After December 31, 1945, this Agreement shall be open for signature on behalf of the government of any country whose membership has been approved in accordance with Article II, Section 2.

(g) By their signature of this Agreement, all governments accept it both on their own behalf and in respect of all their colonies, overseas territories,

af Fonden fra den Dato at regne, da det under Punkt a nævnte Dokument er deponeret paa dens Vegne, dog saaledes, at ingen Regering kan blive Medlem, før denne Overenskomst i Henhold til nærværende Artikels Afsnit 1 træder i Kraft.

c. De Forenede Staters Regering skal underrette Regeringerne i alle de Lande, hvis Navne findes anført i Tillæg A, og alle de Regeringer, der er blevet optaget som Medlemmer i Overensstemmelse med Artikel II, Afsnit 2, om alle Undertegnelser af denne Overenskomst og om enhver Deponering af de under Punkt a omtalte Dokumenter.

d. Samtidig med, at denne Overenskomst undertegnes paa dens Vegne, skal den paagældende Regering til De Forenede Staters Regering indbetale  $\frac{1}{100}$  pCt. af sit samlede Indskud i Guld eller U.S.A.-Dollars til Dækning af Fondens Administrationsudgifter. De Forenede Staters Regering skal indsætte saadanne Midler paa en særlig Indlaanskonto og overdrage dem til Fondens Repræsentantskab, naar det første Møde er blevet sammenkaldt i Henhold til nærværende Artikels Afsnit 3. Dersom denne Overenskomst ikke er traadt i Kraft senest den 31. December 1945, skal De Forenede Staters Regering tilbagebetale saadanne Midler til de Regeringer, der har indbetalt dem.

e. Regeringerne i de Lande, hvis Navne findes anført i Tillæg A, skal indtil den 31. December 1945 have Adgang til i Washington at undertegne denne Overenskomst.

f. Efter den 31. December 1945 skal Regeringerne i de Lande, der i Overensstemmelse med Artikel II, Afsnit 2, er blevet optaget som Medlemmer, have Adgang til at undertegne denne Overenskomst.

g. Ved at undertegne denne Overenskomst tiltræder alle Regeringer denne saavel paa egne Vegne som for alle deres Kolonier, oversøiske Besiddelser,
