

4. The Conference shall make rules laying down the procedure to be followed to secure:

(a) proper consultation with governments and adequate technical preparation prior to consideration by the Conference of proposed recommendations and conventions; and

(b) proper consultation with governments in regard to relations between the Organization and national institutions or private persons.

5. The Conference may make recommendations to any public international organization regarding any matter pertaining to the purpose of the Organization.

6. The Conference may by a two-thirds majority of the votes cast agree to discharge any other functions consistent with the purposes of the Organization which may be assigned to it by governments or provided for by any arrangement between the Organization and any other public international organization.

Article V

(THE EXECUTIVE COMMITTEE)

1. The Conference shall appoint an Executive Committee consisting of not less than nine or more than fifteen members or alternate or associate members of the Conference or their advisers who are qualified by administrative experience or other special qualifications to contribute to the attainment of the purpose of the Organization. There shall be not more than one member from any Member nation. The tenure and other conditions of office of the members of the Executive Committee shall be subject to rules to be made by the Conference.

4. Konferencen fastsætter Regler for den Fremgangsmaade, der skal følges for at tilsikre:

(a) at Forslag til Henstillinger og Konventioner, forinden disses Forelæggelse til Behandling paa Konferencen, behørigt drøftes med Regeringerne og tilrettelægges paa en i teknisk Henseende fyldestgørende Maade; og

(b) at Forholdet mellem Organisationen og Institutioner og Privatpersoner i de enkelte Lande behørigt drøftes med Regeringerne.

5. Konferencen kan fremsætte Forslag over for enhver offentlig international Organisation vedrørende ethvert Anliggende, som maatte have Forbindelse med Organisationens Formaal.

6. Konferencen kan med to Trediedele af de afgivne Stemmer vedtage at udøve enhver anden Virksomhed, der er forenelig med Organisationens Formaal, og som maatte blive overdraget den enten af Regeringerne eller ved Aftaler mellem Organisationen og en anden offentlig international Organisation.

Artikel V

(Eksekutivkomitéen).

1. Konferencen nedsætter en Eksekutivkomité, bestaaende af mindst ni og højst femten af saadanne af Konferencens Medlemmer, Suppleanter, Meddelegerede eller disses Raadgivere, som gennem deres Erfaring i administrativt Arbejde eller paa Grund af andre særlige Kvalifikationer er egnede til at bidrage til Virkeliggørelsen af Organisationens Formaal. Ingen Medlemsstat maa være repræsenteret af mere end eet Medlem. Konferencen vedtager Regler vedrørende Funktionstid og Arbejdsvilkaar for Eksekutivkomitéens Medlemmer.
