

Article XIII**(RELATION TO ANY GENERAL WORLD ORGANIZATION)**

1. The Organization shall, in accordance with the procedure provided for in the following paragraph, constitute a part of any general international organization to which may be entrusted the coordination of the activities of international organizations with specialized responsibilities.

2. Arrangements for defining the relations between the Organization and any such general organization shall be subject to the approval of the Conference. Notwithstanding the provisions of Article XX, such arrangements may, if approved by the Conference by a two-thirds majority of the votes cast, involve modification of the provisions of this Constitution: Provided that no such arrangements shall modify the purposes and limitations of the Organization as set forth in this Constitution.

Article XIV**(SUPERVISION OF OTHER ORGANIZATIONS)**

The Conference may approve arrangements placing other public international organizations dealing with questions relating to food and agriculture under the general authority of the Organization on such terms as may be agreed with the competent authorities of the organization concerned.

Article XV
(LEGAL STATUS)

1. The Organization shall have the capacity of a legal person to perform any legal act appropriate to its purpose which is not beyond the powers granted to it by this Constitution.

Artikel XIII**(Forhold til en almindelig Verdensorganisation).**

1. Organisationen udgør i Overensstemmelse med de i Pkt. 2 fastsatte Regler en Del af en almindelig Verdensorganisation, hvis Formaal det maatte være at tilvejebringe et Samarbejde mellem de, med særlige Opgaver betroede, internationale Organisationer.

2. Aftaler om Fastlæggelsen af Forholdet mellem Organisationen og en saadan almindelig Organisation skal godkendes af Konferencen. Uanset de i Artikel XX indeholdte Regler, kan nærværende Statutters Bestemmelser ændres ved saadanne Aftaler, hvis de godkendes af Konferencen med to Trediedele af de afgivne Stemmer, forudsat at de i Statutterne indeholdte Regler om Organisationens Formaal ikke ændres eller begrænses ved saadanne Aftaler.

Artikel XIV**(Tilsyn med andre Organisationer).**

Konferencen kan godkende Aftaler, der stiller andre internationale Organisationer, der behandler Levnedsmiddel- og Landbrugsspørgsmaal, under Organisationens almindelige Tilsyn paa saadanne Betingelser, som maatte blive aftalt med den paagældende Organisations kompetente Myndigheder.

Artikel XV**(Organisationens retlige Stilling).**

1. Organisationen har en juridisk Persons Beføjelse til at udøve enhver Retshandling, som stemmer overens med dens Formaal og ikke overskrider de den i Statutterne hjemlede Beføjelse.

2. Enhver Medlemsstat paatager sig, i det Omfang det er muligt i Henhold til
