

constitutional procedure, to accord to the Organization all the immunities and facilities which it accords to diplomatic missions, including inviolability of premises and archives, immunity from suit, and exemptions from taxation.

3. The Conference shall make provision for the determination by an administrative tribunal of disputes relating to the conditions and terms of appointment of members of the staff.

Article XVI

(FISH AND FOREST PRODUCTS)

In this Constitution the term "agriculture" and its derivatives include fisheries, marine products, forestry, and primary forestry products.

Article XVII

(INTERPRETATION OF CONSTITUTION)

Any question or dispute concerning the interpretation of this Constitution or any international convention adopted thereunder shall be referred for determination to an appropriate international court or arbitral tribunal in the manner prescribed by rules to be adopted by the Conference.

Article XVIII

(EXPENSES)

1. Subject to the provisions of Article XXV, the Director-General shall submit to the Conference an annual budget covering the anticipated expenses of the Organization. Upon approval of a budget the total amount approved shall be allocated among the Member nations in proportions determined, from time to time, by the Conference. Each Member nation undertakes, subject to the requirements of its constitutional procedure, to contribute to the Organization promptly its share of the expenses so determined.

Artikel XVI

(*Fiskeri- og Skovbrugsprodukter*).

bejdet Stand.

Artikel XVII

(*Fortolkning af Statutterne*).

Eventuelle Spørgsmaal eller Twistig-
heder angaaende Fortolkningen af nærværende
Statutter eller af de i Henhold til
disse vedtagne internationale Konven-
tioner henvises til Afgørelse ved en der-
til egnet international Domstol eller Vold-
giftsret i Overensstemmelse med de af
Konferencen vedtagne Regler.

Artikel XVIII

(*Udgifter*).

1. Generaldirektøren forelægger for
Konferencen et Aarsbudget, der dækker
Organisationens forventede Udgifter, jfr.
dog Bestemmelserne i Artikel XXV.
Efter Budgettets Vedtagelse paaliges
det samlede bevilgede Beløb Medlems-
staterne efter de af Konferencen til en-
hver Tid fastsatte Forholdstal. Enhver
Medlemsstat forpligter sig til, under
Hensyntagen til sin Forfatning, omgaa-
ende at yde Organisationen sin saaledes
fastsatte Andel af Udgifterne.
