

ments which have signed or acceded to the present Convention of any declaration or notification received under paragraphs (1) and (3) of this article stating in each case the date from which the present Convention has become or will cease to be applicable to the territory of territories specified in the declaration or notification, as the case may be.

Article 17.

As from the date of the coming into force of this Convention, the provisions of the International Convention for the Regulation of the Meshes of Fishing Nets and the Size Limits of Fish, signed in London on the 23rd March, 1937, shall, as far as they have been or are applied by any Contracting Government which was a party to that Convention, be replaced by the provisions of this Convention.

Article 18.

After the expiration of three years from the date of its coming into force in accordance with Article 14, this Convention may be denounced by means of a notification in writing addressed to the Government of the United Kingdom of Great Britain and Northern Ireland. The denunciation shall take effect in respect of the Government by which it is made three months after the date of its receipt, and will be notified to the Contracting Governments by the Government of the United Kingdom.

In witness whereof the undersigned, duly authorised thereto, have signed the present Convention.

Done in London the 5th day of April, 1946, in a single copy in the English language. A French text of the Convention shall be prepared and after approval by all the signatory Governments shall be regarded as being of equal validity to the English text. Both

giver alle Regeringer, der har underskrevet eller tiltraadt nærværende Konvention, Underretning om Erklæringer og Meddelelser modtaget i Henhold til Stykke (1) og (3) i denne Artikel, og vil i hvert enkelt Tilfælde give Oplysning om Datoen, fra hvilken Konventionen henholdsvis har fundet Anvendelse paa eller vil ophøre at være gældende for det eller de Omraader, der er angivet i Erklæringen eller Meddelelsen.

Artikel 17.

Fra Datoen for nærværende Konventions Ikrafttræden skal Bestemmelserne i den internationale Konvention angaaende Fastsættelse af Maskestørrelse for Fiskeredskaber og Mindstemaal for Fisk, undertegnet i London den 23. Marts 1937, saa vidt som de har været eller bliver anvendt af en kontraherende Regering, som var Deltager i denne Konvention, erstattes af Bestemmelserne i nærværende Konvention.

Artikel 18.

Efter Udløbet af 3 Aar fra Konventionens Ikrafttræden i Henhold til Artikel 14 kan nærværende Konvention opsiges ved en skriftlig Meddelelse til Regeringen i Det forenede Kongerige Storbritannien og Nordirland. Opsigelsen skal, for saa vidt angaaer den Regering, som har afgivet Meddelelsen, træde i Kraft 3 Maaneder efter Datoen for dens Modtagelse og vil blive meddelt de kontraherende Regeringer af Regeringen i Det forenede Kongerige.

Til Bekræftelse heraf har de undertegnede, dertil behørigt bemyndiget, underskrevet nærværende Konvention.

Udfærdiget i London den 5. April 1946 i et enkelt Eksemplar paa Engelsk. En fransk Tekst af denne Konvention vil blive udarbejdet og skal efter Godkendelse af alle de kontraherende Regeringer anses for at have samme Gyldighed som den engelske Tekst. Begge Tekster af Konventionen skal herefter op-
