

9. All these various proposals were referred by the Conference for examination by Committees constituted for the purpose, and, in the light of reports from these Committees and after a thorough discussion in the course of which the different delegations submitted their views and stated their reservations, the Conference finally recommended that (1) the minimum mesh measurements of 70 mm and 105 mm prescribed by the Convention of 1937 should be raised to 80 mm and 110 mm respectively, and that the areas to which the latter should be applied should include the Icelandic fishing grounds; (2) the size limits below which certain fish should not be retained on board, landed, or sold should be as follows:—

The Norwegian, Swedish, Danish, and Icelandic delegations, whilst accepting these size limits, were of opinion that they were all or some of them still too low and capable of further increase.

10. A Convention to give effect to this recommendation was accordingly drafted and submitted to the Conference for signature and is appended to this Final Act. The Conference recommends that the British Government should be
