

(B) If such application shall be to withdraw from the Loan Account amounts for the purpose of enabling the Borrower to meet the cost of goods not theretofore paid, it shall also set forth:

- (6) A statement of the arrangements under which the amount to be withdrawn from the Loan Account on such application will be applied to the payment of the cost of such goods; and
- (7) An agreement by the Borrower that it will apply or cause to be applied the amount to be withdrawn from the Loan Account on such application only to the payment when and as due of the cost of such goods and that, as promptly as possible thereafter, the Borrower will furnish to the Bank proof satisfactory to the Bank that such amount has been so applied.

Section 3. (A) Each application under this Article shall be in writing in the English language and shall be signed on behalf of the Borrower by its representative or representatives duly authorized for the purpose. Each such application shall be executed and delivered to the Bank in triplicate as the Bank shall from time to time direct. Except as otherwise agreed between the Bank and the Borrower, each such application (except the final application for any currency) shall be for an amount of not less than \$100,000, or the equivalent thereof, in any one currency. Each such application shall relate to a single currency and applications relating to each currency shall be serially numbered in a separate series.

(B) The Borrower will make available to the Bank at all reasonable times original or duplicate receipted bills or invoices or other documents sufficient to show that the expenditures covered by the application have been made for the

(B) Hvis Begæringen gaar ud paa at hæve Beløb paa Laanekontoen for at sætte Laantageren i Stand til at betale for Varer, der ikke allerede er betalt, skal den ogsaa indeholde:

- (6) en Fremstilling af den Maade, paa hvilken det Beløb, der ifølge Begæringen vil være at hæve paa Laanekontoen, skal anvendes til Betaling for saadanne Varer, og
- (7) en Forpligtelse fra Laantagerens Side gaaende ud paa, at denne vil anvende eller lade anvende det Beløb, der ifølge Begæringen skal hæves paa Laanekontoen, udelukkende til Betaling — naar og efterhaanden som disse forfalder — af Udgifterne ved disse Varer, og at Laantageren snarest muligt derefter vil forsyne Banken med Bevisligheder, som denne finder tilfredsstillende, for, at de paagældende Beløb er blevet anvendt paa den omhandlede Maade.

§ 3 (A) Enhver ifølge nærværende Artikel indsendt Begæring skal være skriftlig og affattet paa det engelske Sprog og skal paa Laantagerens Vegne underskrives af en eller flere dertil be myndigede Repræsentanter. Hver Begæring skal udfærdiges og overleveres Banken i tre Eksemplarer, og saaledes som Banken fra Tid til anden maatte bestemme. Med mindre der foreligger anden Aftale mellem Banken og Laantageren, maa hver Begæring (undtagen den sidste Begæring om hvilken som helst Valuta) angaa et Beløb paa mindst 100 000 Dollars eller Mødværdien i anden Valuta. Hver Begæring maa kun angaa en enkelt Valuta, og Begærlinger angaaende hver enkelt Valuta skal nummereres i Rækkefølge i en særskilt Serie.

(B) Laantageren vil forelægge Banken til nærmere Gennemgang af dennes Repræsentanter paa alle rimelige Tider originale eller Duplikat-Eksemplarer af kvitterede Regninger eller Fakturaer eller andre Dokumenter, der paa fyldestgø-
