

the troops at present serving in Germany are relieved in April 1949, and to 1000 men in October 1949.

- (4) Notwithstanding the provisions of paragraph 2 of Article I of the 1947 Agreement, the Danish Government shall be entitled — if it is found desirable — to change over the personnel of the contingent at intervals of not less than 4 months.
- (5) The provisions of paragraph 2 of Article III of the 1947 Agreement shall apply throughout the period mentioned in paragraph (1) above.
- (6) In addition to the items mentioned in Article VII of the 1947 Agreement the facilities to be placed at the disposal of the Danish contingent shall include the provision of Deutschemarks in part payment of the Danish troops up to limits agreed between the Commander of the Danish contingent and the Financial Adviser to the British Military Governor. Such limits, which shall be subject to review, shall be agreed in the first instance not later than 1st January 1949. In the event of any claim for external occupation costs being made in the future against Germany, the amount of such claims will be reduced by the amounts of Deutschemarks provided for the Danish contingent in accordance with this paragraph.
- (7) In accordance with the provisions of paragraph 3 of Article X of the 1947 Agreement, the Danish Government shall pay to the Government of the United Kingdom the balance of the sum of £ 1 457 000 mentioned therein by continuing to pay yearly instalments of £ 291 400 which shall be paid not later than 31st December 1949, 1950 and 1951 respectively. If the Danish contingent is recalled under paragraph 2 of Article III of the 1947 Agreement before 15th May 1951, the question of accelerating payment of any such

4. Uanset bestemmelserne i 1947 overenskomstens art. I, stk. 2, skal den danske regering — såfremt det skønnes ønskeligt — have ret til at udskifte kontingentets personel med mellemrum af mindst fire måneder.
5. Bestemmelsen i 1947 overenskomstens art. III, stk. 2, skal finde anvendelse i hele det tidsrum, der nævnes i ovenstående stk. 1.
6. Foruden de poster, der nævnes i 1947 overenskomstens art. VII, skal de ydelses, der stilles til det danske kontingents rådighed, omfatte levering af Deutsche Mark til delvis lønning af de danske tropper inden for grænser, der aftales mellem chefen for det danske kontingent og den britiske militærguvernørs finansielle rådgiver. Sådanne grænser skal første gang aftales inden den 1. januar 1949 og skal senere kunne tages op til revision. Såfremt der engang i fremtiden måtte blive rejst noget krav mod Tyskland om dækning af besættelsesomkostningerne, skal der i et sådant krav fragå de beløb i Deutsche Mark, der i overensstemmelse med nærværende paragraf er stillet til det danske kontingents rådighed.
7. I overensstemmelse med bestemmelserne i 1947 overenskomstens art. X, stk. 3, skal den danske regering betale det Forenede Kongeriges regering restbeløbet af den deri omhandlede sum £ 1 457 000 ved fortsat at betale årlige afdrag på £ 291 400, der skal betales ikke senere end den 31. december henholdsvis 1949, 1950 og 1951. Hvis det danske kontingent i henhold til 1947 overenskomstens art. III, stk. 2, trækkes tilbage før den 15. maj 1951, skal spørgsmålet om at fremskynde betalingen af afdrag, der endnu ikke måtte være be-
