The final session was held on 8th February, 1949.

As a result of the deliberations of the Conference the International Convention for the Northwest Atlantic Fisheries (hereinafter referred to as the Convention) was formulated and opened for signature on 8th February, 1949, to remain open for signature fourteen days thereafter.

The following resolutions and recommendations were adopted and the following statements were received:—

I.

The International Northwest Atlantic Fisheries Conference resolves:

1. To express its gratitude to the President of the United States of America, Harry S. Truman, for his initiative in convening the present Conference and for its preparation;

2. To express to its Chairman, W. M. Chapman, and its Vice-Chairman, Klaus Sunnanaa, its deep appreciation for the admirable manner in which they have guided the Conference and brought it to a successful conclusion;

3. To express to the officers and staff of the Secretariat its appreciation for their untiring services and diligent efforts in contributing to the fruition of the purposes and objectives of the Conference.

Det afsluttende møde blev afholdt den 8. februar 1949.

Som resultat af konferencens drøftelser blev den mellemfolkelige konvention om fiskeriet i det nordvestlige Atlanterhav (herefter kaldet konventionen) udformet og fremlagt til underskrift den 8. februar 1949 for at forblive fremlagt i fjorten dage derefter.

Følgende resolutioner og henstillinger blev vedtaget, og følgende erklæring blev modtaget:

I.

Den mellemfolkelige konference om fiskeriet i det nordvestlige Atlanterhav *beslutter*:

1. At udtrykke sin taknemmelighed overfor Amerikas Forenede Staters præsident, Harry S. Truman, for hans initiativ ved indkaldelsen af nærværende konference og for dens forberedelse.

2. At udtrykke overfor sin formand, Wilbert M. Chapman, og sin næstformand, Klaus Sunnanaa, sin oprigtige anerkendelse af den beundringsværdige måde, hvorpå de har ledet konferencen og bragt den til en heldig afslutning.

3. At udtrykke overfor sekretariatets embedsmænd og personale sin anerkendelse af deres utrættelige tjeneste og stræbsomme indsats for at bidrage til at nå konferencens hensigt og formål.
