

required under this Agreement, rendered by the vessels operated by them at the Stations, except as agreed by all the Contracting Governments.

ARTICLE X

1. Each Contracting Government shall furnish to the Council such reports as may reasonably be required by the Council concerning the utilization of the services provided by the vessels operated at the Stations.

2. Each Contracting Government operating any of the vessels shall furnish to the Council such reports as may reasonably be required by the Council concerning the operation of the vessel or vessels so operated by it.

3. The Council shall furnish to the Contracting Governments each year a report on the operation and utilization of the Stations based on the reports furnished by Contracting Governments.

ARTICLE XI

Any Contracting Government may agree with any other Contracting Government to take over all or any of its obligations under this Agreement. Any such agreement shall be notified by the Contracting Governments concerned to the Secretary-General of the Organization who shall notify the other Contracting Governments.

ARTICLE XII

The Organization shall be reimbursed for its extraordinary expenses incidental to this Agreement, so far as possible from the contributions provided for in Article V, and subject to the provisions of paragraph 3 of Article III, from any contributions in cash received by it under the provisions of Article XVII. Any balance remaining from such contributions after the extraordinary expenses of the Organization have been met shall be allocated by the Council to the Contracting Governments on an equitable

tjenester, der i henhold til nærværende overenskomsts bestemmelser udføres på en station af skibe, der drives af nævnte regering, medmindre sådant måtte vedtages af alle de kontraherende regeringer.

ARTIKEL X

1. Hver kontraherende regering skal tilsende Rådet sådanne rapporter, som dette med rimelighed kan kræve, vedrørende anvendelsen af de tjenester, der ydes af de på stationerne drevne skibe.

2. Hver kontraherende regering, der driver skib eller skibe på stationer, skal tilsende Rådet sådanne rapporter, som Rådet med rimelighed kan kræve, vedrørende driften af det skib eller de skibe, der drives af den pågældende regering.

3. Rådet skal tilsende de kontraherende regeringer en årlig rapport vedrørende driften og anvendelsen af stationerne baseret på de af de kontraherende regeringer indsendte rapporter.

ARTIKEL XI

En kontraherende regering kan træffe aftale med en hvilken som helst anden kontraherende regering om at overtage samtlige eller nogle af de denne i henhold til nærværende overenskomst påhvilende forpligtelser. En sådan aftale skal af vedkommende kontraherende regeringer meddeles Organisationens generalsekretær, som skal underrette de andre kontraherende regeringer herom.

ARTIKEL XII

De ekstraordinære udgifter, Organisationen måtte have i forbindelse med nærværende overenskomst, skal så vidt muligt refunderes gennem de i Artikel V fastsatte bidrag, samt, med forbehold af de i Artikel III, stykke 3, indeholdte bestemmelser, gennem de kontante bidrag, der modtages af Organisationen i henhold til de i Artikel XVII, indeholdte bestemmelser. Efter at Organisationens ekstraordinære udgifter er afholdt, fordeler Rådet ethvert eventuelt overskydende beløb af sådanne bidrag
