

**4.** In the case of Iceland paragraph 3 of Article 3 of the Convention shall apply as if the date referred to in this paragraph were "1st January 1970".

**5.** In the case of Iceland Article 6 of the Convention shall apply as if

(a) the date referred to in sub-paragraph (a) of paragraph 3 were "1st January 1972";

(b) the date referred to in (ii) of sub-paragraph (b) of paragraph 3 were "1st January 1975"; and

(c) the date referred to in sub-paragraph (c) of paragraph 3 were "1st July 1970".

**6.** In the case of Iceland Article 10 of the Convention shall apply as if

(a) the date referred to in paragraph 2 were "31st December 1974";

(b) the date referred to in paragraph 3 were "1st January 1975";

(c) the words "On 1st July, 1960, Member States shall ..." appearing at the beginning of paragraph 5 read "On the date of the entry into force of the Convention in relation to Iceland, Iceland shall ...";

(d) the calendar year appearing at the end of paragraph 5 read "1969";

(e) the words "Member States shall ensure that the quota to be established on 1st July, 1960 ..." appearing in the first sentence of paragraph 6 read "Iceland shall ensure that the quota to be established at the date of the entry into force of the Convention in relation to Iceland ...";

(f) the words "On 1st July, 1961, and on 1st July in each succeeding year, Member States shall ..." appearing at the beginning of paragraph 7 read "On 1st January, 1971, and on 1st January in each succeeding year, Iceland shall ..."; and

(g) the calendar year mentioned in sub-paragraph (b) of paragraph 11 were "1969".

**7.** In the case of Iceland Annex A to the Convention shall apply as if

(a) the dates referred to in paragraph 2 were "1st January, 1970" and "31st December, 1974" respectively and

(b) the date referred to in paragraph 4 were "1st January, 1970".

**§ 4.** I forhold til Island skal konventionens artikel 3, stk. 3, finde anvendelse, som om det i nævnte stykke anførte tidspunkt var „1. januar 1970“.

**§ 5.** I forhold til Island skal konventionens artikel 6 finde anvendelse, som om

(a) det i stk. 3(a) nævnte tidspunkt var „1. januar 1972“,

(b) det i stk. 3(b) (ii) nævnte tidspunkt var „1. januar 1975“, og

(c) det i stk. 3(c) nævnte tidspunkt var „1. juli 1970“.

**§ 6.** I forhold til Island skal konventionens artikel 10 finde anvendelse, som om

(a) det i stk. 2 nævnte tidspunkt var „31. december 1974“.

(b) det i stk. 3 nævnte tidspunkt var „1. januar 1975“,

(c) ordene „Den 1. juli 1960 skal medlemsstaterne“ i begyndelsen af stk. 5 var „Fra tidspunktet for konventionens ikrafttræden i forhold til Island, skal Island...“,

(d) det i slutningen af stk. 5 nævnte kalenderår var „1969“,

(e) ordene i stk. 6, første punktum, „skal medlemsstaterne sikre, at det kontingent, der oprettes den 1. juli 1960 ....“ var „skal Island sikre, at det kontingent, der oprettes på tidspunktet for konventionens ikrafttræden i forhold til Island ....“,

(f) ordene „Den 1. juli 1961 og den 1. juli hvert følgende år skal medlemsstaterne ....“ i begyndelsen af stykke 7 var „Den 1. januar 1971 og den 1. januar hvert følgende år skal Island ....“ og

(g) det i stk. 11(b) nævnte kalenderår var „1969“.

**§ 7.** I forhold til Island skal tillæg A til konventionen finde anvendelse, som om

(a) de i stk. 2 nævnte tidspunkter var henholdsvis „1. januar 1970“ og „31. december 1974“ og

(b) det i stk. 4 nævnte tidspunkt var „1. januar 1970“.
