(c) Consistent with the provisions of Resolution 1721 (XVI) of the General Assembly of the United Nations, the executive organ shall send to the Secretary General of the United Nations, and to the Specialized Agencies concerned, for their information, an annual report on the activities of INTELSAT.

Article XXII.

(Depositary).

(a) The Government of the United States of America shall be the Depositary for this Agreement, with which shall be deposited declarations made pursuant to paragraph (b) of Article XIX of this Agreement, instruments of ratification, acceptance, approval or accession, requests for provisional application, and notifications of ratification, acceptance or approval of amendments, of decisions to withdraw from INTELSAT, or of termination of the provisional application of this Agreement.

(b) This Agreement, of which the English, French and Spanish texts are equally authentic, shall be deposited in the archives of the Depositary. The Depositary shall transmit certified copies of the text of this Agreement to all Governments that have signed it or deposited instruments of accession to it, and to the International Telecommunication Union, and shall notify those Governments, and the International Telecommunication Union, of signatures, of declarations made pursuant to paragraph (b) of Article XIX of this Agreement, of the deposit of instruments of ratification, acceptance, approval or accession, of requests for provisional application, of commencement of the sixty-day period referred to in paragraph (a) of Article XX of this Agreement, of the entry into force of this Agreement, of notifications of ratification, acceptance or approval of amendments, of the entry into force of amendments, of decisions to withdraw from INTELSAT, of withdrawals and of terminations of provisional application of this Agreement. (c) I overensstemmelse med de Forenede Nationers generalforsamlings resolution 1721 (XVI) skal det udøvende organ tilsende de Forenede Nationers generalsekretær og de pågældende særlige organer en årlig beretning om INTELSAT's virksomhed til deres orientering.

Artikel XXII.

(Depositary).

(a) Regeringen for de Forenede Stater i Amerika skal være depositar for nærværende overenskomst, sammen med hvilken der skal deponeres erklæringer udstedt i henhold til artikel XIX (b) i nærværende overenskomst, ratifikations-, accept-, godkendelses- eller tiltrædelsesdokumenter, anmodninger om foreløbig anvendelse samt meddelelser om ratificering, accept eller godkendelse af ændringer, om beslutninger om udtræden af INTELSAT eller om ophør af den foreløbige anvendelse af nærværende overenskomst.

(b) Nærværende overenskomst, hvoraf den engelske, den franske og den spanske tekst er lige autentiske, skal deponeres i depositarens arkiv. Depositaren skal fremsende bekræftede kopier af nærværende overenskomsts tekst til alle regeringer, som har undertegnet den eller har deponeret dokumenter om tiltrædelse til den, samt til den Internationale Telekommunikations Union og skal underrette de nævnte regeringer og den Internationale Telekommunikations Union om undertegnelser, om erklæringer udstedt i henhold til artikel XIX (b) i nærværende overenskomst, om deponering af ratifikations-, accept-, godkendelses- eller tiltrædelsesdokumenter, om anmodninger om foreløbig anvendelse, om påbegyndelsen af den i artikel XX (a) i nærværende overenskomst omhandlede tres-dages periode, om nærværende overenskomsts ikrafttræden, om meddelelser om ratifikation, accept eller godkendelse af ændringer, om ændringers ikrafttræden, om udtræden samt om ophør af foreløbig anvendelse af nærværende overenskomst. Meddelelse om påbe-
