

London and Washington. Any State which does not sign this Convention before its entry into force in accordance with paragraph 3 of this Article may accede to it at any time.

2. This Convention shall be subject to ratification by the signatory States. Instruments of ratification and instruments of accession shall be deposited with the Governments of the Union of Soviet Socialist Republics, the United Kingdom of Great Britain and Northern Ireland, and the United States of America, which are hereby designated the Depositary Governments.

3. This Convention shall enter into force thirty days following the date of the deposit of instruments of ratification by ten States signatory to this Convention which participated in the Montreal Conference.

4. For other States, this Convention shall enter into force on the date of entry into force of this Convention in accordance with paragraph 3 of this Article, or thirty days following the date of deposit of their instruments of ratification or accession, whichever is later.

5. The Depositary Governments shall promptly inform all signatory and acceding States of the date of each signature, the date of deposit of each instrument of ratification or accession, the date of entry into force of this Convention, and other notices.

6. As soon as this Convention comes into force, it shall be registered by the Depositary Governments pursuant to Article 102 of the Charter of the United Nations and pursuant to Article 83 of the Convention on International Civil Aviation (Chicago, 1944).

#### Article 16

1. Any Contracting State may denounce this Convention by written notification to the Depositary Governments.

2. Denunciation shall take effect six months following the date on which notification is received by the Depositary Governments.

IN WITNESS WHEREOF the undersigned Plenipotentiaries, being duly authorized thereto by their Governments, have signed this Convention.

i Moskva, London og Washington. Enhver stat, som ikke undertegner konventionen før dens ikrafttræden i henhold til stk. 3, kan når som helst tiltræde konventionen.

2. Konventionen skal ratificeres af de undertegnende stater. Ratifikations- og tiltrædelsesdokumenter skal deponeres hos regeringen i Unionen af sovjetiske socialistiske republikker, Det forenede Kongerige Storbritannien og Nordirland samt i Amerikas forenede Stater, som herved udpeges som depositarregeringerne.

3. Konventionen træder i kraft 30 dage efter at 10 stater, som har undertegnet konventionen og deltaget i Montreal-konferencen, har deponeret deres ratifikationsdokument.

4. For andre stater træder konventionen i kraft fra tidspunktet for dens ikrafttræden i henhold til stk. 3, eller 30 dage efter datoen for deponeringen af statens ratifikations- eller tiltrædelsesdokument, hvis dette tidspunkt ligger efter det førstnævnte.

5. Depositarregeringerne skal straks underrette alle undertegnende og tiltrædende stater om datoen for enhver undertegnelse, for deponeringen af hver enkelt ratifikations- eller tiltrædelsesdokument, for konventionens ikrafttræden og om enhver anden meddelelse.

6. Så snart konventionen træder i kraft, skal den registreres af depositarregeringerne i henhold til artikel 102 i De forenede Nationers pagt og i henhold til artikel 83 i konventionen om international civil luftfart (Chicago 1944).

#### Artikel 16

1. Enhver kontraherende stat kan opsig denne konvention ved skriftlig meddelelse til depositarregeringerne.

2. Opsigelsen får virkning 6 måneder efter den dato, da depositarregeringerne modtager meddelelsen.
