

of receipt of the notification by the Secretary-General of the Organization.

Article 9

1. A Conference for the purpose of revising or amending the present Convention may be convened by the Organization.

2. The Organization shall convene a Conference of the Contracting Parties to the present Convention for revising or amending it at the request of not less than one-third of the Contracting Parties.

Article 10

A Contracting Party may make reservations corresponding to those which it has validly made to the Paris or Vienna Convention. A reservation may be made at the time of signature, ratification, acceptance, approval or accession.

Article 11

1. The present Convention shall be deposited with the Secretary-General of the Organization.

2. The Secretary-General of the Organization shall:

- (a) inform all States which have signed or acceded to the present Convention of:
 - (i) each new signature and each deposit of an instrument together with the date thereof;
 - (ii) any reservation made in conformity with the present Convention;
 - (iii) the date of entry into force of the present Convention;
 - (iv) any denunciation of the present Convention and the date on which it takes effect;
 - (v) the extension of the present Convention to any territory under paragraph 1 of Article 8 and of the termination of any such extension under the provisions of paragraph 4 of that Article stating in each case the date on which the present Convention has been or will cease to be so extended;

Artikel 9

1. Organisationen kan sammenkalde en konference til revision eller ændring af denne konvention.

2. Organisationen skal på begæring af mindst $\frac{1}{3}$ af de kontraherende parter sammenkalde en konference af de kontraherende parter til revision eller ændring af denne konvention.

Artikel 10

En kontraherende stat kan tage forbehold svarende til dem, den gyldigt har taget med hensyn til Paris- eller Wienkonventionen. Et forbehold kan tages ved undertegnelsen, ratifikationen, godkendelsen, tilslutningen eller tiltrædelsen.

Artikel 11

1. Denne konvention skal deponeres hos Organisationens generalsekretær.

2. Organisationens generalsekretær skal

- a) underrette alle stater, som har undertegnet eller tiltrådt denne konvention, om
 - i) enhver ny undertegnelse og enhver deponering af et dokument samt datoen herfor;
 - ii) ethvert forbehold taget i overensstemmelse med denne konvention;
 - iii) datoen for konventionens ikrafttræden;
 - iv) enhver opsigelse af konventionen samt datoen for opsigelsens ikrafttræden;
 - v) konventionens udvidelse til at omfatte et territorium i henhold til artikel 8, stk. 1, og om ophøret af en sådan udvidelse i henhold til bestemmelserne i den nævnte artikels stk. 4, med angivelse i hvert enkelt tilfælde af datoen for denne udvidelse eller for ophøret heraf;
