

mit to the Government of the United States of America one one-hundredth of one percent of its total subscription in gold or United States dollars for the purpose of meeting administrative expenses of the Fund. The Government of the United States of America shall hold such funds in a special deposit account and shall transmit them to the Board of Governors of the Fund when the initial meeting has been called. If this Agreement has not come into force by December 31, 1945, the Government of the United States of America shall return such funds to the governments that transmitted them.

(e) This Agreement shall remain open for signature at Washington on behalf of the governments of the countries whose names are set forth in Schedule A until December 31, 1945.

(f) After December 31, 1945, this Agreement shall be open for signature on behalf of the government of any country whose membership has been approved in accordance with Article II, Section 2.

(g) By their signature of this Agreement, all governments accept it both on their own behalf and in respect of all their colonies, overseas territories, all territories under their protection, suzerainty, or authority, and all territories in respect of which they exercise a mandate.

(h) Subsection (d) above shall come into force with regard to each signatory government as from the date of its signature.

[The signature and depositary clause reproduced below followed the text of Article XX in the original Articles of Agreement]

Done at Washington, in a single copy which shall remain deposited in the archives of the Government of the United States of America, which shall transmit certified copies to all governments whose names are set forth in Schedule A and to all governments whose membership is approved in accordance with Article II, Section 2.

pågældende regering til De forenede Staters regering indbetale $\frac{1}{100}$ pct. af sit samlede indskud i guld eller US-dollars til dækning af fondens administrationsudgifter. De forenede Staters regering skal indsætte sådanne midler på en særlig indlånskonto og overdrage dem til fondens repræsentantskab, når det første møde er blevet sammenkaldt. Dersom denne overenskomst ikke er trådt i kraft senest den 31. december 1945, skal De forenede Staters regering tilbagebetale sådanne midler til de regeringer, der har indbetalt dem.

e. Regeringerne i de lande, der er anført i tillæg A, skal indtil den 31. december 1945 have adgang til i Washington at undertegne denne overenskomst.

f. Efter den 31. december 1945 skal regeringerne i de lande, der i overensstemmelse med artikel II, afsnit 2, er blevet optaget som medlemmer, have adgang til at undertegne denne overenskomst.

g. Ved at undertegne denne overenskomst træder alle regeringer denne såvel på egne vegne som for alle deres kolonier, oversøiske besiddelser, alle landområder under deres protektorat, overhøjhed eller anden myndighed, og alle landområder, over hvilke de udøver et mandat.

h. De under pkt. d ovenfor nævnte bestemmelser træder for hver enkelt signatarregerings vedkommende i kraft fra den dag, den har undertegnet overenskomsten.

Udfærdiget i Washington i et enkelt eksemplar, som skal forblive beroende i De forenede Staters regerings arkiv, hvilken regering skal tilstille alle de regeringer, hvis navne er anført i tillæg A, samt de regeringer, der i overensstemmelse med artikel II, afsnit 2, er blevet optaget som medlemmer af fonden, bekræftede afskrifter.
