PART V IMPLEMENTING REGULATIONS TO PART V OF THE CONVENTION

Rule 55

Content of the notice of opposition

The notice of opposition shall contain:

- (a) the name and address of the opponent and the State in which his residence or principal place of business is located, in accordance with the provisions of Rule 26, paragraph 2(c);
- (b) the number of the European patent against which opposition is filed, and the name of the proprietor and title of the invention;
- (c) a statement of the extent to which the European patent is opposed and of the grounds on which the opposition is based as well as an indication of the facts, evidence and arguments presented in support of these grounds;
- (d) if the opponent has appointed a representative, his name and the address of his place of business, in accordance with the provisions of Rule 26, paragraph 2(c).

Rule 56

Rejection of the notice of opposition as inadmissible

(1) If the Opposition Division notes that the notice of opposition does not comply with the provisions of Article 99, paragraph 1, Rule 1, paragraph 1, and Rule 55, subparagraph (c), or does not provide sufficient identification of the patent against which opposition has been filed, it shall reject the notice of opposition as inadmissible unless these deficiencies have been remedied before expiry of the opposition period.

(2) If the Opposition Division notes that the notice of opposition does not comply with the provisions of Rule 55 other than

Regel 55

Indsigelsesskrivelsens indhold

Indsigelsesskrivelsen skal indeholde:

- a) indsigerens navn og adresse samt den stat, i hvilken han har bopæl eller sæde, i overensstemmelse med regel 26, stk. 2, c);
- b) nummeret på det europæiske patent, mod hvilket der fremsættes indsigelse, samt patenthaverens navn og opfindelsens benævnelse;
- c) en erklæring om, i hvilket omfang der fremsættes indsigelse mod det europæiske patent, og på hvilke grunde indsigelsen støttes, såvel som en angivelse af de kendsgerninger, bevisligheder og anbringender, der kan fremføres for disse grunde;
- d) hvis indsigeren har udnævnt en fuldmægtig, dennes navn og forretningsadresse i overensstemmelse med regel 26, stk. 2, c).

Regel 56

Afvisning af indsigelsen

1) Hvis indsigelsesafdelingen finder, at indsigelsen ikke opfylder bestemmelserne i artikel 99, stk. 1, regel 1, stk. 1, og regel 55, c), eller at det europæiske patent, mod hvilket der er fremsat indsigelse, ikke er tilstrækkelig næje angivet, afdiser indsigelsesafdelingen indsigelsen, medmindre de pågældende mangler afhjælpes inden udløbet af indsigelsesfristen.

2) Hvis indsigelsesafdelingen finder, at indsigelsen ikke opfylder de i regel 55 indeholdte bestemmelser med undtagelse af de i
