

9. Each member elected to the Executive Board may appoint an alternate from among the Members whose votes are deemed to have elected it.

*C. Distribution of votes in the Executive Board.*

1. In the Executive Board a member elected by a Governor or Governors representing a Member or Members in category I shall be entitled to cast the votes of that Member or Members. Where the member represents more than one Member it may cast separately the votes of the Members it represents.

2. If the voting rights of a Member of category I should change between the times provided for the election of members of the Executive Board:

(a) there shall be no change in such members as a result thereof;

(b) voting rights of each member of the Executive Board shall be adjusted as of the effective date of the change in voting rights of the Member or Members it represents;

(c) the Governor of a new Member of category I may designate an existing member of the Executive Board to represent it and cast its votes until the next election of members of the Board. During such period a member so designated shall be deemed to have been elected by the Governor which so designated it.

*D. Amendments.*

1. The Governors representing category I Members may by a unanimous decision amend the provisions of sub-parts A and B. Unless otherwise decided, the amendment shall have immediate effect. The President shall be informed of any amendment to sub-parts A and B.

2. The Governors representing category I Members may amend the provisions of sub-part C by a decision taken with a majority of 75 per cent of the total voting power of such Governors. Unless otherwise decided, the amendment shall have immediate effect. The President shall be informed of any amendment to sub-part C.

9. Hvert bestyrelsesmedlem kan udpege en stedfortræder blandt de medlemmer, hvis stemmer anses for at have indvalgt det.

*C. Stemmefordelingen i bestyrelsen.*

1. I bestyrelsen skal et medlem, der er valgt af en eller flere repræsentanter for et eller flere medlemmer af kategori I, være berettiget til at afgive dette eller disse medlemmers stemmer. Hvor medlemmet repræsenterer flere end et medlem, kan det særskilt afgive stemmerne for de medlemmer, det repræsenterer.

2. Hvis et kategori I-medlems stemmerrettigheder skulle blive ændret i løbet af bestyrelsesmedlemernes valgperiode:

(a) skal der ikke af denne grund ske nogen ændring med hensyn til disse medlemmer,

(b) skal hvert bestyrelsesmedlems stemmerrettigheder tilpasses fra det tidspunkt, hvor ændringen af det eller de repræsenterede medlemmers stemmerrettigheder trådte i kraft,

(c) kan repræsentanten for et nyt medlem i kategori I udpege et siddende medlem af bestyrelsen til at repræsentere det og afgive dets stemmer indtil det næste bestyrelsesvalg. I denne periode skal et således udpeget medlem anses for at være valgt af den udpegende repræsentant.

*D. Ändringer.*

1. Kategori I-medlemmers repræsentanter kan enstemmigt ændre bestemmelserne i afsnit A og B. Medmindre andet er bestemt, træder ændringen straks i kraft. Præsidenten skal underrettes om alle ændringer til afsnit A og B.

2. Kategori I-medlemmers repræsentanter kan ændre bestemmelserne i afsnit C ved en beslutning truffet med et flertal på 75 procent af disse repræsentanters samlede stemmetal. Medmindre andet er bestemt, træder ændringen straks i kraft. Præsidenten skal underrettes om alle ændringer til afsnit C.
