

full powers of its representative or was expressed during the negotiation.

2. The consent of an international organization to be bound by a treaty is expressed by an act of formal confirmation when:

(a) the treaty provides for such consent to be expressed by means of an act of formal confirmation;

(b) it is otherwise established that the negotiating States and negotiating organizations or, as the case may be, the negotiating organizations were agreed that an act of formal confirmation should be required;

(c) the representative of the organization has signed the treaty subject to an act of formal confirmation; or

(d) the intention of the organization to sign the treaty subject to an act of formal confirmation appears from the full powers of its representative or was expressed during the negotiation.

3. The consent of a State or of an international organization to be bound by a treaty is expressed by acceptance or approval under conditions similar to those which apply to ratification or, as the case may be, to an act of formal confirmation.

#### Article 15

##### *Consent to be bound by a treaty expressed by accession*

The consent of a State or of an international organization to be bound by a treaty is expressed by accession when:

(a) the treaty provides that such consent may be expressed by that State or that organization by means of accession;

(b) it is otherwise established that the negotiating States and negotiating organizations or, as the case may be, the negotiating organizations were agreed that such consent may be expressed by that State or the organization by means of accession; or

(c) all the parties have subsequently agreed that such consent may be expressed by that State or that organization by means of accession.

2. En international organisations samtykke til at være bundet af en traktat udtrykkes ved formel bekræftelse, når:

(a) traktaten foreskriver, at sådant samtykke skal udtrykkes ved formel bekræftelse;

(b) det på anden måde er godtgjort, at de forhandlende stater og de forhandlende organisationer respektive de forhandlende organisationer var enige om, at formel bekræftelse var påkrævet;

(c) organisationens repræsentant har undertegnet traktaten under forbehold af formel bekræftelse; eller

(d) organisationens ønske om at undertegne traktaten under forbehold af formel bekræftelse fremgår af dens repræsentants fuldmagt eller blev udtrykt under forhandlingerne.

3. En stats eller en international organisations samtykke til at være bundet af en traktat udtrykkes ved accept eller godkendelse under lignende betingelser, som gælder med hensyn til ratifikation respektive formel bekræftelse.

#### Artikel 15

##### *Samtykke til at være bundet af en traktat udtrykt ved tiltrædelse*

En stats eller en international organisations samtykke til at være bundet af en traktat udtrykkes ved tiltrædelse, når:

(a) traktaten foreskriver, at sådant samtykke kan udtrykkes af den pågældende stat eller den pågældende organisation ved tiltrædelse;

(b) det på anden måde er godtgjort, at de forhandlende stater og de forhandlende organisationer respektive de forhandlende organisationer var enige om, at sådant samtykke kan udtrykkes af den pågældende stat eller den pågældende organisation ved tiltrædelse; eller

(c) samtlige deltagere efterfølgende er blevet enige om, at et sådant samtykke kan udtrykkes af den pågældende stat eller den pågældende organisation ved tiltrædelse.
