all the negotiating States and negotiating organizations or, as the case may be, all the negotiating organizations.

3. When the consent of a State or of an international organization to be bound by a treaty is established on a date after the treaty has come into force, the treaty enters into force for that State or that organization on that date, unless the treaty otherwise provides.

4. The provisions of a treaty regulating the authentication of its text, the establishment of consent to be bound by the treaty, the manner or date of its entry into force, reservations, the functions of the depositary and other matters arising necessarily before the entry into force of the treaty apply from the time of the adoption of its text.

Article 25*Provisional application*

1. A treaty or a part of a treaty is applied provisionally pending its entry into force if:

- (a) the treaty itself so provides; or
- (b) the negotiating States and negotiating organizations or, as the case may be, the negotiating organizations have in some other manner so agreed.

2. Unless the treaty otherwise provides or the negotiating States and negotiating organizations or, as the case may be, the negotiating organizations have otherwise agreed, the provisional application of a treaty or a part of a treaty with respect to a State or an international organization shall be terminated if that State or that organization notifies the States and organizations with regard to which the treaty is being applied provisionally of its intention not to become a party to the treaty.

3. Når en stats eller en international organisations samtykke til at være bundet af en traktat gives på et tidspunkt efter traktatens ikrafttræden, træder traktaten i kraft for denne stat eller denne organisation på det nævnte tidspunkt, medmindre traktaten bestemmer andet.

4. En traktats bestemmelser om bekræftelse af dens tekst, meddelelse af samtykke til at være bundet af traktaten, måden og datoen for dens ikraftræden, forbehold, depositarens funktioner og andre forhold, der nødvendigvis opstår inden traktatens ikraftræden, finder anvendelse fra det tidspunkt, da dens tekst vedtages.

Artikel 25*Foreløbig anvendelse*

1. En traktat eller en del af en traktat anvendes foreløbigt i aftenen af dens ikraftræden, såfremt:

- (a) traktaten selv indeholder bestemmelse herom; eller
- (b) de forhandlende stater og forhandlende organisationer respektive de forhandlende organisationer på anden måde er blevet enige herom.

2. Medmindre traktaten foreskriver andet, eller de forhandlende stater og forhandlende organisationer respektive de forhandlende organisationer er blevet enige om andet, skal den foreløbige anvendelse af en traktat eller af en del af en traktat i forhold til en stat eller en international organisation ophøre, hvis denne stat eller denne organisation meddeler de stater og organisationer, mellem hvilke traktaten anvendes foreløbigt, at det er dens hensigt ikke at blive deltager i traktaten.
