

*Artikel 20*

Artiklerne 21 – 27 i Fondskonventionen af 1971 og overskriften til disse artikler ophæves.

*Artikel 21*

Artikel 29 i Fondskonventionen af 1971 ændres som følger:

1. Stk. 1 ændres som følger:

1. Direktøren er fondens øverste administrative embedsmænd. Under iagttagelse af de ham af forsamlingen givne instruktioner skal han udføre de opgaver, der er tillagt ham i denne konvention, i fondens interne reglement og af forsamlingen.

2. I stk. 2, litra e), slettes ordene »og eksekutivkomiteen«

3. I stk. 2, litra f), slettes ordene »,henholdsvis eksekutivkomiteen,«.

4. Stk. 2, litra g), ændres som følger:

g) udarbejde i samråd med forsamlingens formand, og offentliggøre en rapport over fondens virksomhed i det forudgående kalenderår,

5. I stk. 2, litra h), slettes ordet », eksekutivkomiteen«.

*Artikel 22*

I artikel 31, stk. 1, i Fondskonventionen af 1971 slettes ordene »i eksekutivkomiteen og«.

*Artikel 23*

Artikel 32 i Fondskonventionen af 1971 ændres som følger:

1. I indledningen slettes ordene »og eksekutivkomiteen«.

2. I litra b) slettes ordene »og eksekutivkomiteen«.

*Article 20*

Articles 21 to 27 of the 1971 Fund Convention and the heading to these articles are deleted.

*Article 21*

Article 29 of the 1971 Fund Convention is amended as follows:

1. Paragraph 1 is replaced by the following text:

1. The Director shall be the chief administrative officer of the Fund. Subject to the instructions given to him by the Assembly, he shall perform those functions which are assigned to him by this Convention, the Internal Regulations of the Fund and the Assembly.

2. In paragraph 2(e) the words »or the Executive Committee« are deleted.

3. In the paragraph 2(f) the words »or the Executive Committee, as the case may be,« are deleted.

4. Paragraph 2(g) is replaced by the following text:

(g) prepare, in consultation with the Chairman of the Assembly, and publish a report of the activities of the Fund during the previous calendar year;

5. In paragraph 2(h) the words », the Executive Committee« are deleted.

*Article 22*

In Article 31, paragraph 1, of the 1971 Fund Convention, the words »on the Executive Committee and« are deleted.

*Article 23*

Article 32 of the 1971 Fund Convention is amended as follows:

1. In the opening phrase the words »and the Executive Committee« are deleted.

2. In subparagraph (b) the words »and the Executive Committee« are deleted.
