

*Artikel 37**Fondens likvidation*

1. Såfremt denne protokol ophører at gælde, skal fonden dog:

- a) opfylde sine forpligtelser i anledning af enhver hændelse, der er indtruffet, før konventionen ophørte at gælde,
- b) kunne udøve sine rettigheder til afgifter i den udstrækning, disse afgifter er nødvendige til opfyldelse af de under a) nævnte forpligtelser, herunder de afgifter til fondens administration, som er nødvendige til dette formål.

2. Forsamlingen skal tage alle nødvendige skridt for at afslutte fondens likvidation, herunder en ligelig fordeling af de resterende beholdninger mellem de personer, der har betalt afgifter til fonden.

3. Med henblik på opfyldelsen af sine opgaver ifølge denne artikel beholder fonden sin egenskab af en juridisk person.

*Artikel 38**Deponering*

1. Denne protokol og ændringer antaget i henhold til artikel 33 skal deponeres hos organisationens generalsekretær.

2. Organisationens generalsekretær skal:

- a) underrette alle stater, som har undertegnet eller tiltrådt protokollen, om:
 - i) enhver ny undertegnelse eller deponeering af instrument med angivelse af datoer herfor,
 - ii) enhver erklæring og meddelelse i henhold til artikel 30 herunder erklæringer og tilbagekaldelser, der anses for at være i overensstemmelse med denne artikel,
 - iii) datoer for protokollens ikrafttræden,
 - iv) den dato, hvor opsigelser i henhold til artikel 31 skal foretages,
 - v) ethvert forslag til ændring af beløbsgrænser for erstatning fremsat i henhold til artikel 33, stk. 1,

*Article 37**Winding up of the Fund*

1. If this Protocol ceases to be in force, the Fund shall nevertheless:

- (a) meet its obligations in respect of any incident occurring before the Protocol ceased to be in force;
- (b) be entitled to exercise its rights to contributions to the extent that these contributions are necessary to meet the obligations under subparagraph (a), including expenses for the administration of the Fund necessary for this purpose.

2. The Assembly shall take all appropriate measures to complete the winding up of the Fund including the distribution in an equitable manner of any remaining assets among those persons who have contributed to the Fund.

3. For the purposes of this Article the Fund shall remain a legal person.

*Article 38**Depositary*

1. This Protocol and any amendments accepted under Article 33 shall be deposited with the Secretary-General of the Organization.

2. The Secretary-General of the Organization shall:

- (a) inform all States which have signed or acceded to this Protocol of:
 - (i) each new signature or deposit of an instrument together with the date thereof,
 - (ii) each declaration and notification under Article 30 including declarations and withdrawals deemed to have been made in accordance with that Article;
 - (iii) the date of entry into force of this Protocol;
 - (iv) the date by which denunciations provided for in Article 31 are required to be made;
 - (v) any proposal to amend limits of amounts of compensation which has been made in accordance with Article 33, paragraph 1;
