

*Relations between the State Party and the Organization*

4. In order to fulfil its obligations under this Convention, each State Party shall designate or establish a National Authority to serve as the national focal point for effective liaison with the Organization and other States Parties. Each State Party shall notify the Organization of its National Authority at the time that this Convention enters into force for it.
  
5. Each State Party shall inform the Organization of the legislative and administrative measures taken to implement this Convention.
6. Each State Party shall treat as confidential and afford special handling to information and data that it receives in confidence from the Organization in connection with the implementation of this Convention. It shall treat such information and data exclusively in connection with its rights and obligations under this Convention and in accordance with the provisions set forth in the Confidentiality Annex.
  
7. Each State Party undertakes to cooperate with the Organization in the exercise of all its functions and in particular to provide assistance to the Technical Secretariat.

## ARTICLE VIII

### *The organization*

#### A. General provisions

1. The States Parties to this Convention hereby establish the Organization for the Prohibition of Chemical Weapons to achieve the object and purpose of this Convention, to ensure the implementation of its provisions, including those for international verification of compliance with it, and to provide a forum for consultation and cooperation among States Parties.
  
2. All States Parties to this Convention shall be members of the Organization. A State Party shall not be deprived of its membership in the Organization.

*Forbindelserne mellem en deltagende stat og Organisationen*

4. For at opfylde sine forpligtelser i henhold til denne konvention skal enhver deltagende stat udpege eller oprette en National Myndighed, som skal tjene som nationalt kontaktorgan med henblik på at sikre en effektiv forbindelse til Organisationen og andre deltagende stater. Enhver deltagende stat skal underrette Organisationen om sin Nationale Myndighed på tidspunktet for denne konventions ikrafttræden for dens vedkommende.
5. Enhver deltagende stat skal underrette Organisationen om de lovgivningsmæssige og administrative foranstaltninger, som er truffet til gennemførelse af konventionen.
6. Enhver deltagende stat skal gøre de oplysninger og de data, som den modtager i fortrølighed fra Organisationen i forbindelse med gennemførelsen af denne konvention, til genstand for fortrolig og særlig behandling. Den skal alene behandle sådanne oplysninger og data i forbindelse med sine rettigheder og forpligtelser i henhold til denne konvention og i overensstemmelse med bestemmelserne i Fortrolighedsbillet.
7. Enhver deltagende stat påtager sig at samarbejde med Organisationen under dennes udførelse af alle sine opgaver og i særdeleshed at bistå Det Tekniske Sekretariat.

## ARTIKEL VIII

### *Organisationen*

#### A. Generelle bestemmelser

1. De i denne konvention deltagende stater opretter herved Organisationen for Forbud mod Kemiske Våben for at opfylde formålet og hensigten med denne konvention, for at sikre gennemførelsen af dens bestemmelser, herunder bestemmelserne om international verifikation af konventionens overholdelse, samt for at skabe et forum for samråd og samarbejde mellem de deltagende stater.
2. Alle de i denne konvention deltagende stater skal være medlemmer af Organisationen. En deltagende stat skal ikke fratas sit medlemskab af Organisationen.
