- (b) any Party that has made a declaration with respect to additional regional implementation annexes or amendments to regional implementation annexes in accordance with article 34, paragraph 4, in which case any such annex or amendment shall enter into force for such a Party on the ninetieth day after the date of deposit with the Depositary of its instrument of ratification, acceptance, approval or accession with respect to such annex or amendment.

4. If the adoption of an annex or an amendment to an annex involves an amendment to the Convention, that annex or amendment to an annex shall not enter into force until such time as the amendment to the Convention enters into force.

### Article 32

#### *Right to vote*

1. Except as provided for in paragraph 2, each Party to the Convention shall have one vote.

2. Regional economic integration organizations, in matters within their competence, shall exercise their right to vote with a number of votes equal to the number of their member States that are Parties to the Convention. Such an organization shall not exercise its right to vote if any of its member States exercises its right, and vice versa.

## PART VI FINAL PROVISIONS

### Article 33

#### *Signature*

This Convention shall be opened for signature at Paris, on 14-15 October 1994, by States Members of the United Nations or any of its specialized agencies or that are Parties to the Statute of the International Court of Justice and by regional economic integration organizations. It shall remain open for signature, thereafter, at the United Nations Headquarters in New York until 13 October 1995.

- b) parter, der har afgivet en erklæring vedrørende yderligere regionale gennemførelsesbilag eller ændringer til regionale gennemførelsesbilag i overensstemmelse med artikel 34, stk. 4, idet det pågældende bilag eller den pågældende ændring i så fald træder i kraft for sådanne parter på den 90. dag efter datoen for deponering hos depositaren af deres instrument for ratifikation, accept, godkendelse eller tiltrædelse af det pågældende bilag eller den pågældende ændring.
4. Hvis vedtagelsen af et bilag eller en ændring til et bilag indebærer en ændring af konventionen, træder bilaget eller ændringen til et bilag først i kraft, når ændringen til konventionen selv træder i kraft.

### Artikel 32

#### *Stemmeret*

1. Hver part i konventionen har én stemme, jf. dog stk. 2.

2. Regionale organisationer for økonomisk integration tildeles, til udøvelse af deres stemmeret på områder, der hører under deres kompetence, et antal stemmer svarende til antallet af de af deres medlemsstater, der er parter i konventionen. Disse organisationer anvender ikke deres stemmeret, såfremt deres medlemsstater anvender deres stemmeret, og omvendt.

## DEL VI AFSLUTTENDE BESTEMMELSER

### Artikel 33

#### *Undertegnelse*

Denne konvention åbnes for undertegnelse i Paris den 14.-15. oktober 1994 for stater, der er medlemmer af De Forenede Nationer eller en hvilken som helst af FN's særorganisationer eller parter i Den Internationale Domstols statut, og for regionale organisationer for økonomisk integration. Den forbliver derefter åben for undertegnelse i De Forenede Nationers hovedsæde i New York indtil den 13. oktober 1995.
