

tion, they shall seek a settlement of the dispute through negotiation or any other peaceful means of their choice, including submission of the dispute to the European Committee on Crime Problems, to an arbitral tribunal whose decisions shall be binding upon the Parties, or to the International Court of Justice, as agreed upon by the Parties concerned.

Article 43

Denunciation

1. Any Party may, at any time, denounce this Convention by means of a notification addressed to the Secretary General of the Council of Europe.

2. Such denunciation shall become effective on the first day of the month following the expiration of a period of three months after the date of receipt of the notification by the Secretary General.

3. The present Convention shall, however, continue to apply to the enforcement under Article 14 of confiscation for which a request has been made in conformity with the provisions of this Convention before the date on which such a denunciation takes effect.

Article 44

Notifications

The Secretary General of the Council of Europe shall notify the member States of the Council and any State which has acceded to this Convention of:

- a. any signature;
- b. the deposit of any instrument of ratification, acceptance, approval or accession;
- c. any date of entry into force of this Convention in accordance with Articles 36 and 37;
- d. any reservation made under Article 40, paragraph 1;
- e. any other act, notification or communication relating to this Convention.

In witness whereof the undersigned, being duly authorised thereto, have signed this Convention.

konvention skal de forsøge at afgøre tvisten ved forhandling eller andre fredelige midler efter eget valg, herunder indbringelse af tvisten for European Committee on Crime Problems, for en voldgiftsinstans, hvis afgørelse skal være bindende for parterne, eller for Den Internationale Domstol, efter aftale mellem de berørte parter.

Artikel 43

Opsigelse

1. Enhver part kan på ethvert tidspunkt opsig denne konvention ved notifikation stilet til Europarådets generalsekretær.

2. En sådan opsigelse træder i kraft den første dag i den måned, der følger efter udløbet af en periode på tre måneder efter datoen for generalsekretærens modtagelse af notifikationen.

3. Denne konvention skal imidlertid fortsat finde anvendelse på tvangsfuldbyrdelse i henhold til artikel 14 af konfiskation, som der er anmodet om i overensstemmelse med bestemmelserne i denne konvention før datoen for opsigelsens ikrafttræden.

Artikel 44

Notifikationer

Europarådets generalsekretær skal notificere Europarådets medlemsstater og enhver stat, der har tiltrådt denne konvention, om:

- a. undertegning,
- b. deponering af ratifikations-, godkendelses- eller tiltrædelsesinstrumenter,
- c. datoen for denne konventions ikrafttræden i overensstemmelse med artikel 36 og 37,
- d. forbehold taget i medfør af artikel 40, stk. 1,
- e. enhver anden handling, notifikation eller meddelelse vedrørende denne konvention.

Parterne har – efter behørigt at være bemyndiget hertil – undertegnet denne konvention.
