The Government of the Kingdom of Denmark,
The Government of the Federal Republic of Germany, and
The Government of the Republic of Poland -

Considering the accession of the Republic of Poland to the North Atlantic Treaty of 4 April 1949 as amended on 17 October 1951 and to the Agreement between the Parties to the North Atlantic Treaty regarding the Status of their Forces (NATO SOFA) of 19 June 1951.

Taking note of the Memorandum of Understanding between their Ministries of Defence of 17 August 1995,

Endorsing the decision taken by their Ministers of Defence on 16 April 1998 on the establishment of the Multinational Corps Northeast (hereinafter referred to as the Corps) -

have agreed as follows:

Article 1

Purpose of the Convention

(1) The purpose of this Convention is to define the responsibilities of the Contracting Parties, the principles of organisation and co-operation in the Corps, and the status of its Headquarters.

(2) Implementing arrangements will be concluded by Ministries of Defence.

Article 2

Definitions

For the purpose of this Convention the following definitions shall apply:

a) **Corps.** All elements as mentioned in Article 4 of this Convention including personnel,

Beslutningen truffet af deres forsvarsministre den 16. april 1998 om etablering af Multinational Corps Northeast (herefter benævnt korpset) -

aftalt følgende:

Artikel 1

Konventionens formål

1. Formålet med denne konvention er at definere pligterne for de kontraherende parter, principperne for organisation og samarbejde i korpset og status for dets hovedkvarter.

2. Implementeringsaftaler kan vedtages af forsvarsministrene.

Artikel 2

Definitioner
