6. The GRECO's report may contain recommendations addressed to the member undergoing the evaluation in order to improve its domestic laws and practices to combat corruption. The GRECO shall invite the member to report on the measures taken to follow these recommendations.

### Article 16

#### *Public Statements*

1. The Statutory Committee may issue a public statement when it believes that a member remains passive or takes insufficient action in respect of the recommendations addressed to it as regards the application of the Guiding Principles.

2. The Statutory Committee, in its composition restricted to the members who are parties to the instruments concerned, may issue a public statement when it believes that a member remains passive or takes insufficient action in respect of the recommendations addressed to it as regards the implementation of an instrument adopted in pursuance of the Programme of Action against Corruption.

3. The Statutory Committee shall inform the member concerned and provide an opportunity for the member to submit further comments before confirming its decision to issue a public statement referred to in paragraphs 1 and/or 2 above.

### Article 17

#### *The GRECO's financial resources*

1. The budget of the GRECO shall be financed through the annual compulsory contributions of its members;

2. The GRECO may receive additional voluntary contributions from its members;

3. The GRECO may also receive voluntary contributions from interested international institutions;

6. GRECO's rapporter kan indeholde anbefalinger til medlemmet, der evalueres, med henblik på forbedring af medlemmets nationale lovgivning og praksis vedrørende bekæmpelse af korruption. GRECO skal opfordre medlemmet til at rapportere om, hvilke foranstaltninger der træffes for at efterleve anbefalingerne.

### Artikel 16

#### *Pressemeldelse*

1. Styringskomitéen kan udsende en pressemeldelse, hvis den finder, at et medlem forholder sig passivt eller handler utilstrækkeligt med hensyn til de modtagne anbefalinger vedrørende anvendelsen af de vejledende retningslinier.

2. Styringskomitéen, der udelukkende er sammensat af medlemmer, som er part i den pågældende retsakt, kan udsende en pressemeldelse, hvis den finder, at et medlem forholder sig passivt eller handler utilstrækkeligt med hensyn til de modtagne anbefalinger vedrørende gennemførelsen af en retsakt vedtaget i henhold til handlingsplanen mod korruption.

3. Styringskomitéen skal informere det pågældende medlem samt give medlemmet mulighed for at fremsætte yderligere bemærkninger, inden den træffer beslutning om at udsende en pressemeldelse som nævnt i stk. 1 og/eller stk. 2.

### Artikel 17

#### *GRECO's finansiering*

1. GRECO's budget finansieres gennem årlige obligatoriske bidrag fra medlemmerne.

2. GRECO kan modtage yderligere frivillige bidrag fra medlemmerne.

3. GRECO kan endvidere modtage frivillige bidrag fra interesserede internationale organisationer.
