

**Article 115****Funds of the Court and of the Assembly of States Parties**

The expenses of the Court and the Assembly of States Parties, including its Bureau and subsidiary bodies, as provided for in the budget decided by the Assembly of States Parties, shall be provided by the following sources:

- (a) Assessed contributions made by States Parties;
- (b) Funds provided by the United Nations, subject to the approval of the General Assembly, in particular in relation to the expenses incurred due to referrals by the Security Council.

**Article 116****Voluntary contributions**

Without prejudice to article 115, the Court may receive and utilize, as additional funds, voluntary contributions from Governments, international organizations, individuals, corporations and other entities, in accordance with relevant criteria adopted by the Assembly of States Parties.

**Article 117****Assessment of contributions**

The contributions of States Parties shall be assessed in accordance with an agreed scale of assessment, based on the scale adopted by the United Nations for its regular budget and adjusted in accordance with the principles on which that scale is based.

**Article 118****Annual audit**

The records, books and accounts of the Court, including its annual financial statements, shall be audited annually by an independent auditor.

## PART 13.

*FINAL CLAUSES***Article 119****Settlement of disputes**

1. Any dispute concerning the judicial functions of the Court shall be settled by the decision of the Court.

**Artikel 115****Midler tilhørende domstolen og forsamlingen af deltagerstater**

Udgifter, der påhviler domstolen og forsamlingen af deltagerstater, herunder dens bureau og underordnede organer, i henhold til det af forsamlingen af deltagerstater vedtagne budget, skal dækkes af følgende kilder:

- (a) pålignede bidrag fra deltagerstater,
- (b) midler fra De Forenede Nationer, under forbehold af Generalforsamlingens godkendelse, navnlig i relation til udgifter, der pådrages som følge af henvisninger fra Sikkerhedsrådet.

**Artikel 116****Frivillige bidrag**

Uden at foregribe artikel 115 kan domstolen som yderligere midler modtage og benytte frivillige bidrag fra regeringer, internationale organisationer, fysiske og juridiske personer samt fra anden side i overensstemmelse med de kriterier, som vedtages af forsamlingen af deltagerstater.

**Artikel 117****Påligning af bidrag**

Deltagerstaternes bidrag skal pålignes i overensstemmelse med en aftalt påligningsskala på grundlag af den skala, som De Forenede Nationer har vedtaget for sit ordinære budget og justeret i overensstemmelse med de principper, hvorpå denne skala er baseret.

**Artikel 118****Årlig revision**

Domstolens protokoller, bøger og regnskaber, herunder dens årsregnskab, skal revideres hvert år af en uafhængig revisor.

## KAPITEL 13.

*AFSLUTTENDE BESTEMMELSER***Artikel 119****Bilæggelse af tvister**

1. Enhver tvist vedrørende domstolens judicielle funktioner skal afgøres af domstolen.
