

3. Regional economic integration organizations shall, in their instruments relating to formal confirmation or in their instruments of accession, declare the extent of their competence with respect to the matters governed by the Convention. These organizations shall also inform the Depositary, who shall in turn inform the Parties, of any substantial modification in the extent of their competence.

Article 36

Entry into force

1. This Convention shall enter into force on the ninetieth day following the date of deposit of the fortieth instrument of ratification, acceptance, approval, formal confirmation or accession with the Depositary.

2. For each State that ratifies, accepts or approves the Convention or accedes thereto after the conditions set out in paragraph 1 of this Article for entry into force have been fulfilled, the Convention shall enter into force on the ninetieth day following the date of deposit of its instrument of ratification, acceptance, approval or accession.

3. For each regional economic integration organization depositing an instrument of formal confirmation or an instrument of accession after the conditions set out in paragraph 1 of this Article for entry into force have been fulfilled, the Convention shall enter into force on the ninetieth day following the date of its depositing of the instrument of formal confirmation or of accession.

4. For the purposes of this Article, any instrument deposited by a regional economic integration organization shall not be counted as additional to those deposited by States Members of the organization.

Article 37

Depositary

The Secretary-General of the United Nations shall be the Depositary of this Convention and amendments thereto and of protocols and annexes adopted in accordance with Articles 28, 29 and 33.

3. Regionale økonomiske integrationsorganisationer skal i de instrumenter, der relaterer til deres formelle bekræftelse eller tiltrædelse, fastslå omfanget af deres kompetence med hensyn til forhold, der falder under konventionen. Disse organisationer skal også informere depositaren, som på sin side skal informere parterne, om væsentlige ændringer i deres kompetence.

Artikel 36

Ikraftræden

1. Denne konvention skal træde i kraft på den halvfemsindstyvende dag efter deponeringen hos depositaren af det fyrettyvende instrument vedrørende ratifikation, accept, godkendelse, formel bekræftelse eller tiltrædelse af konventionen.

2. For hver stat som ratificerer, accepterer eller godkender konventionen, eller som tiltræder den, efter at betingelserne for ikraftræden fastlagt i stykke 1 i denne artikel er opfyldt, skal konventionen træde i kraft på den halvfemsindstyvende dag efter datoen for deponering af instrumenter vedrørende ratificering, accept, godkendelse eller tiltrædelse.

3. For hver regional økonomisk integrationsorganisation, der deponerer et formelt bekræftelses- eller ratifikationsinstrument, efter at betingelserne for ikraftræden fastlagt i stykke 1 i denne artikel er opfyldt, skal konventionen træde i kraft på den halvfemsindstyvende dag efter datoene for deponering af det formelle bekræftelses- eller tiltrædelsesinstrument.

4. Indenfor rammerne af denne artikels bestemmelser, skal et instrument deponeret af en regional økonomisk integrationsorganisation, ikke medtælles som et yderligere instrument ud over dem, der er deponeret af organisationens medlemsstater.

Artikel 37

Depositar

FNs Generalsekretær skal være depositar for denne konvention og tilkommende ændringer og for protokoller og bilag vedtaget i henhold til artiklerne 28, 29 og 33.
