2. The Special Fund may be financed through voluntary contributions made by Governments, intergovernmental and non-governmental organizations and other private or public entities.

## PART VII

### *Final provisions*

#### **Article 27**

1. The present Protocol is open for signature by any State that has signed the Convention.

2. The present Protocol is subject to ratification by any State that has ratified or acceded to the Convention. Instruments of ratification shall be deposited with the Secretary-General of the United Nations.

3. The present Protocol shall be open to accession by any State that has ratified or acceded to the Convention.

4. Accession shall be effected by the deposit of an instrument of accession with the Secretary-General of the United Nations.

5. The Secretary-General of the United Nations shall inform all States that have signed the present Protocol or acceded to it of the deposit of each instrument of ratification or accession.

#### **Article 28**

1. The present Protocol shall enter into force on the thirtieth day after the date of deposit with the Secretary-General of the United Nations of the twentieth instrument of ratification or accession.

2. For each State ratifying the present Protocol or acceding to it after the deposit with the Secretary-General of the United Nations of the twentieth instrument of ratification or accession, the present Protocol shall enter into force on the thirtieth day after the date of deposit of its own instrument of ratification or accession.

#### **Article 29**

The provisions of the present Protocol shall extend to all parts of federal States without any limitations or exceptions.

## Kapitel VII

### *Afsluttende bestemmelser*

#### **Artikel 27**

1. Denne protokol kan undertegnes af enhver stat, der har undertegnet konventionen.

2. Denne protokol kan ratificeres af enhver stat, der har ratificeret eller tiltrådt konventionen. Ratifikationsinstrumenter skal deponeres hos De Forenede Nationers generalsekretær.

3. Denne protokol kan tiltrædes af enhver stat, der har ratificeret eller tiltrådt konventionen.

4. Tiltrædelse sker ved deponering af et tiltrædelsesinstrument hos De Forenede Nationers generalsekretær.

5. De Forenede Nationers generalsekretær underretter alle de stater, der har undertegnet eller tiltrådt denne protokol, om deponering af ethvert ratifikations- eller tiltrædelsesinstrument.

#### **Artikel 28**

1. Denne protokol træder i kraft den 30. dag efter datoen for deponeringen af det tyvende ratifikations- eller tiltrædelsesinstrument hos De Forenede Nationers generalsekretær.

2. For enhver stat, der ratificerer denne protokol eller tiltræder den efter deponeringen af det tyvende ratifikations- eller tiltrædelsesinstrument hos De Forenede Nationers generalsekretær, træder protokollen i kraft på den 30. dag efter deponeringen af statens eget ratifikations- eller tiltrædelsesinstrument.

#### **Artikel 29**

Bestemmelserne i denne protokol gælder for alle dele af føderale stater uden nogen begrænsninger eller undtagelser.
