

2. This Convention is subject to ratification, acceptance or approval. The instruments of ratification, acceptance or approval shall be deposited with the Secretary-General of the United Nations.

3. This Convention shall be open to accession by any State. The instruments of accession shall be deposited with the Secretary-General of the United Nations.

Article 25

1. This Convention shall enter into force on the thirtieth day following the date of the deposit of the twenty-second instrument of ratification, acceptance, approval or accession with the Secretary-General of the United Nations.

2. For each State ratifying, accepting, approving or acceding to the Convention after the deposit of the twenty-second instrument of ratification, acceptance, approval or accession, the Convention shall enter into force on the thirtieth day after deposit by such State of its instrument of ratification, acceptance, approval or accession.

Article 26

1. A State Party may propose an amendment to this Convention. The proposed amendment shall be submitted to the depositary, who circulates it immediately to all States Parties.

2. If the majority of the States Parties request the depositary to convene a conference to consider the proposed amendments, the depositary shall invite all States Parties to attend such a conference to begin no sooner than three months after the invitations are issued.

3. The conference shall make every effort to ensure amendments are adopted by consensus. Should this not be possible, amendments shall be adopted by a twothirds majority of all States Parties. Any amendment adopted at the conference shall be promptly circulated by the depositary to all States Parties.

2. Denne konvention skal ratificeres, accepteres eller godkendes. Ratifikations-, accept- eller godkendelsesinstrumenterne skal deponeres hos De Forenede Nationers generalsekretær.

3. Denne konvention står åben for tiltrædelse af enhver stat. Tiltrædelsesinstrumenterne skal deponeres hos De Forenede Nationers generalsekretær.

Artikel 25

1. Denne konvention træder i kraft den 30. dag efter datoen for deponeringen af det 22. ratifikations-, accept-, godkendelses- eller tiltrædelsesinstrument hos De Forenede Nationers generalsekretær.

2. For enhver stat, der ratificerer, accepterer, godkender eller tiltræder konventionen efter deponeringen af det 22. ratifikations-, accept-, godkendelses- eller tiltrædelsesinstrument, træder konventionen i kraft den 30. dag efter, at den pågældende stat har deponeret sit ratifikations-, accept-, godkendelses- eller tiltrædelsesinstrument.

Artikel 26

1. En kontraherende stat kan foreslå ændringer til konventionen. Den foreslæde ændring skal indgives til depositaren, som omgående rundersender den til alle kontraherende stater.

2. Hvis flertallet af de kontraherende stater anmoder depositaren om at indkalde en konference til behandling af de foreslæde ændringer, skal depositaren indbyde alle kontraherende stater til at deltage i en sådan konference, som tidligst må starte tre måneder efter, at indbydelserne er sendt ud.

3. Konferencens deltagere skal gøre deres yderste for at sikre, at ændringerne vedtages ved konsensus. Hvis dette ikke er muligt, kan ændringerne vedtages med et flertal på 2/3 af alle de kontraherende stater. Enhver ændring vedtaget på konferencen skal omgående rundersendes af depositaren til alle de kontraherende stater.
